Seviqc Brežice also faces very similar problems at the national level and understanding the importance of festivals and established brands in culture at the local level as well.

I firmly support the Minister of Culture Dr Asta Vrečko, who started her mandate in a great way and prepared a good timeline for solving problems. I only disagree with her in that the expert commissions of the Ministry of Culture are professional and independent. This is specified in the rules on expert commissions, but neither one nor the other applies. However, I believe that

advocating for expert commissions is part of the minister's strategic approach to cutting the Gordian knot.

The Ministry of Culture has also been violating the law for years when conducting public tenders. This causes great material, moral and business damage. The problems have to be solved only by the applicants, malnourished and exhausted in the fight for culture, while the culprits are hidden in the pillows of the public services.
