## Projekt LAS Srce Slovenije na temo varovanja alpskih voda je nominiran za evropsko nagrado ARIA 2023

Projekt sodelovanja na temo varovanja voda v Kamniško-Savinjskih Alpah se je kot slovenski predstavnik umestil med 24 finalistov za evropsko nagrado ARIA 2023. V okviru projekta Mreža vodnih poti v Kamniško-Savinjskih Alpah je nastala nova pohodniška pot okoli Kamniško-Savinjskih Alp, dolga 190 km, razdeljena na 11 etap. The cooperation project on the topic of water protection in the Kamnik-Savinjske Alps, as a Slovenian representative, is among the 24 finalists for the European ARIA Award 2023. As part of the project Network of Waterways in the Kamnik-Savinjske Alps, a new hiking trail around the Kamnik-Savinjske Alps was created, 190 km long, divided into 11 stages. It passes by more than 100 water springs where you can quench your thirst. The main purpose of the project is to raise awareness of the importance of drinking water conservation.
