The petition with which we demand the right to defense in the co-financing of non-governmental culture , and which is published in English and Slovenian, collected 524 signatures on the online platform. petition before the summer at the Culture Committee of the National Assembly and all parliamentary groups except the Left, where we expect a meeting in the next few days.
