Donacije iz dohodnine 2024 v kulturi 2024 Personal Income Tax Donations in the Cultural Sector

Donacije iz dohodnine v kulturi so pokazatelj podpore državljanov delovanju nevladnih organizacij

Donacije iz dohodnine so del obvezne dajatve državljanov v proračun Republike Slovenije, ki se ji država odpove v korist nevladnih organizacij. Posameznik lahko do 1 % svoje dohodnine nameni organizacijam po lastni izbiri, zato višina teh donacij predstavlja pokazatelj pomena, ki ga javnost pripisuje posamezni nevladni organizaciji.

Na podlagi javno dostopnih podatkov FURS in AJ PES smo pripravili [razpredelnico](#). Med 425 organizacijami smo glede na skupen znesek donacij (3.675,91 EUR) na 30. mestu (povprečje znaša 1.234,31 EUR), glede na število donatorjev pa s 132 donatorji na 22. mestu (povprečno število donatorjev po organizaciji je 40,41). Iskreno čestitamo vsem organizacijam, ki ste prejele več podpore, in se zahvaljujemo svojim donatorjem, ki jih zaradi davčne tajnosti ne moremo prepoznati. Zahvaljujemo se vsem, ki ste svojo donacijo iz dohodnine namenili nam.

Skupno je donacijo iz dohodnine namenilo 688.590 ljudi, kar predstavlja 62,6 % od približno 1.100.000 oseb, ki imajo v posameznem letu obdavčljiv dohodek in jim je država obračunala dohodnino. Vabimo vse, ki svoje donacije še niste namenili nobeni organizaciji, da nas podprete in svojo donacijo iz dohodnine namenite nam.



Pruski kralj Friderik II. Veliki je bil tudi odličen flautist. Njegov učitelj Johann Joachim Quantz je zanj napisal več kot 300 koncertov. Kot mecen nemške in evropske kulture je skupaj z Bachovimi sinovi in drugo kulturno elito močno zaznamoval medkulturni dialog.

Frederick II the Great, King of Prussia, was also an excellent flautist. His teacher Johann Joachim Quantz composed over 300 concertos for him. As a patron of German and European culture, together with the sons of Bach and other cultural elites, he left a significant mark on intercultural dialogue.

Personal Income Tax Donations in the Cultural Sector are an indicator of citizens' support for non-governmental organisations.

Personal income tax donations are a part of the obligatory contribution by citizens to the budget of the Republic of Slovenia, which the state renounces in favour of non-governmental organisations. Each individual may allocate up to 1% of their income tax to organisations of their own choice. The total amount of such donations thus reflects the significance that the public attributes to a particular NGO.

Based on publicly available data from FURS and AJPES, we have prepared the [table](#). Among 425 organisations, we rank 30th in terms of the total amount donated (EUR 3,675.91; the average is EUR 1,234.31), and 22nd in terms of the number of donors, with 132 supporters (the average number of donors per organisation is 40.41).

We sincerely congratulate all organisations that received greater support and thank our own donors, whose identities we cannot know due to tax confidentiality. We are grateful to everyone who allocated their personal income tax donation to us.

A total of 688,590 individuals made such donations, which represents 62.6% of the approximately 1,100,000 people who received a taxable income and had their income tax assessed in the given year. We invite everyone who has not yet allocated their donation to any organisation to support us by assigning it to our work.
