

Seviqc Collegiumartis

Program Seviqc že ves čas od pričetka v letu 1982 gradi na mednarodnem povezovanju. Festival Seviqc je od leta 1997 vključil v program 2.324 izvajalcev iz 54 držav z 5.253 nastopi (glej <https://www.seviqc.si/porocilo.html> / VIII, Skupno število izvajalcev 1997-2024).

Seviqc Collegiumartis je vsebinski sklop festivala Seviqc. V 2024 smo mednarodno povezovanje nadgradili s povezovanjem slovenskih umetnikov z mednarodnimi na istem koncertu. S tem nadaljujemo tudi v 2025 in kasneje. Izvedba lahko vključuje povezavo slovenskih umetnikov z ansamblom druge države ali skupen nastop slovenskih in mednarodnih umetnikov v ad hoc ansamblu.

Na strani <https://www.seviqc.si/for-artists.html> je objavljen dosje Slovenian Early Music Scene, seznam umetnikov slovenske scene stare glasbe, ki jih podpira program Seviqc, ki smo ga oblikovali prav zaradi teh povezav.

Umetnikom nudimo pogoje, kot so opisani na tej spletni strani v dokumentu Application guidelines (Smernice za prijavnico programa), ob tem pa še dodaten dan za skupne vaje z bivanjem in prehrano. Umetniki, ki bi sodelovali, bi se morali že prej povezati po mailu, videu ali telefonu, da se bolje spoznajo. Vsekakor bi bila predhodno tudi video konferenca umetnikov in festivala Seviqc.

Since its inception in 1982, the Seviqc programme has been building on international networking. Since 1997, the Seviqc festival has included 2,324 artists from 54 countries with 5,253 performances (see <https://www.seviqc.si/report.html> / VIII, Number of performers 1997-2024).

Seviqc Collegiumartis is a content component of the Seviqc festival. In 2024, we upgraded international networking by connecting Slovenian artists with international ones at the same concert. We will continue this in 2025 and beyond. The performance may include a connection between Slovenian artists and an ensemble from another country or a joint performance of Slovenian and international artists in an ad hoc ensemble.

The Slovenian Early Music Scene dossier, a list of artists from the Slovenian early music scene supported by the Seviqc program, has been published on the website <https://www.seviqc.si/for-artists.html>, which we have created precisely because of these connections.

We offer artists the conditions described on this website in the Application guidelines document, as well as an additional day for joint rehearsals with accommodation and meals. Artists who would like to participate should connect in advance by email, video or phone to get to know each other better. In any case, there would also be a video conference of the artists and the Seviqc festival beforehand.

The schedule would look something like this:

Day 1: arrival
Day 2: rehearsals
Day 3: rehearsals and concert
Day 4: departure
